Civil Service Collective Bargaining Act

Title VII of the Civil Service Reform Act of 1978, commonly referred to as the " Federal Service Labor-Management Relations Statute " (FSLMRS), recognizes the right of most federal employees to engage in collective bargaining with respect to their conditions of employment. In 2016, 27.4% of all federal employees were members of a union.

The Interplay of Civil Service Law and Collective ...

The Michigan Civil Service Commission has established an Employee-Employer Relations Rule which creates a system of collective bargaining for determining conditions of employment including compensation for state classified employees. Upon election of an exclusive representative, all conditions of employment for unit employees are established through negotiations between the Office of the State Employer, as the Governor's representative, and the exclusive representative.

However, in separate elections in 1974 San Antonio voters approved collective bargaining for the City ' s Firefighters and Police Officers. Since that time, the City and the associations for firefighters and police officers have entered into collective bargaining agreements for addressing pay, benefits, hours and other terms of employment.

(a) A state or local civil service provision prevails over a collective bargaining contract under this chapter unless the collective bargaining contract specifically provides otherwise. (b) A civil service provision may not be repealed or modified by arbitration or judicial action but may be interpreted or enforced by an arbitrator or court.

New Collective Bargaining Agreements Approved On December 12, 2018, the Civil Service Commission approved new agreements for employees represented by the UAW, MCO, SEIU 517M S&E Unit, HSS Unit and Technical Unit, MSEA and AFSCME Council 25. Non-economic provisions of the agreements took effect January 1, 2019 and will expire December 31, 2021.

Created under Ohio Revised Code Section 4117.10, the Office of Collective Bargaining serves as the principle representative of the state as an employer and negotiates the state ' s labor contracts. This office presently serves approximately 70 state agencies, boards and commissions, offering technical assistance and expertise to agency management staff on contract interpretation, civil service, and many employee relations matters.
